Final Demand to Avoid Enforcement Action

Our records indicate that you have an outstanding balance with the Michigan Department of Treasury (Treasury). As of the date of this letter, Treasury has not received a response, or payment, to resolve the outstanding liability. The attached detail of your account has been included for your review.

By paying the "Balance Due Immediately" within 10 days of this letter, you will avoid:

- Levy enforcement action, resulting in a deduction from wages, bank accounts, or other financial assets for your outstanding liability. Expenses incurred in collection of this liability will be charged to you.
- Money payable to you from the State of Michigan being withheld and applied to your outstanding liability.
- Money payable to you from the City being withheld and applied to your City debt.

In addition, while there is an outstanding tax liability, you may be subject to a lien being filed against your real or personal property. Once filed, the lien will remain open until the balance is resolved. Penalty and interest will continue to accrue as provided by statute.

Treasury offers the following payment options:

- Pay online at michigan.gov/collectionseservice using a checking account, savings account, or debit/credit card. Payment for business debts must be made using the business Federal Employer Identification Number (FEIN).
- Pay by phone using a checking or savings account by calling the Contact Phone Number listed above. Customer service representatives cannot accept payment via debit/credit cards.
- Pay by mail using the attached Payment Voucher and return envelope.
