- If you have already paid the balance, upload copies of the cancelled checks, confirmation numbers, or other supporting documentation, along with a copy of this notice at [dor.sc.gov/doc-upload](http://dor.sc.gov/doc-upload). You'll need your FEIN, SSN, or South Carolina ID (SID) and the Letter ID shown at the top of this letter.
