Sent fax to Ms. Lund:

My client, Michael Walker, is currently being levied with Acorns Security and Bank of America.

Mr. Walker had moved and didn't receive notice of these levies until January 16, when BOA sent him a letter. He contacted me on the 17th. Since the 18th, I have been trying to reach someone by phone, leaving several messages, speaking to a GM, and by email. It is my understanding that there was also a Form 9297 sent to him, which he has not received.

My client is willing to work with the IRS for a solution, but the current levies are causing him a severe hardship as they have taken all his money. Some of that money was to support his business, which is his only source of income.

After speaking with you yesterday morning, you asked me to fax F-2848 and you would call me back. I did fax it but have not received a return call.

I'm requesting a copy of the Form 9297 be sent to me and to have the levy released until we have had an opportunity to comply with the F9297.

Called & left message for Ms. Lund. I was a little stern, and told her I didn't know what else I could do to 01/25/2024 15:35 talk to her but I have left multiple messages, faxed requests for calls/communication, etc. If I am doing something wrong or she would prefer me to handle it another way, would she please let me know.

Ms Lund called me back. She is very evasive in her speech by not commenting any more than absolutely necessary to answer a question. For example, I told her I have been trying to send her some financials but didn't want to try faxing 80+ pages. I had asked for a "SendMyReply" code. She said "you 01/25/2024 15:40 can fax 80 pages". She finally told me I can email the documents to her as well.

> She wants specific bills that TP needs to pay to consider "hardship". She point blank asked if he's getting evicted, several times.

I have never met anyone that could care less about someone else as she appears to.

The situation with Mr. Walker is not as cut & dry as most cases.

In 2023 TP liquidated all investments and closed several companies he was involved with. This was to focus more on his core business model which resulted in 2 companies – Rubicon Performance, LLC., (Rubicon) and Balance Benefits, PLLC (Balance).

The cash from the liquidations was funneled into these two entities.

Rubicon is profitable and generates cash flow. Balance, on the other hand, is not. At this point, cash flow from Rubicon is supporting the lack of cash flow of Balance. TP is also occasionally using personal funds to keep Balance operating. TP believes that in 6 to 9 months, Balance will generate positive cash flow.

01/26/2024 15:44 Until then, he maintained an account with \$75,000 which was to cover his personal living expenses & taxes until Balance generates cash flow.

All of this to show why TP can not expect pay checks or compensation for the at least the next 6 months. All the money that was levied from the account was his living expenses for the next 6 months.

TP has been in filing & paying compliance for the past 3 years and we believe that he will be able to pay off a large portion (or all) of his balance by the end of this year.

We therefore urgently & respectfully request that the levy on the Bank of America account be fully released.

I asked her if she received the information I had sent her. She said she did. I asked her about the release of levy. She said the levy proceeds had already posted a couple days ago.

I asked her why she would do that when I have tried to contact her every day for the last 3 weeks, sent her what she asked for when she asked for it, but could never make contact with her. She said she returned my calls. I agreed and said that she had returned them, but only a week or so after I call.

I would call her to follow up multiple times and she wouldn't return my call until several days later. I told her that I was a retired RO and I know how these things work. There was no reason for her to be treating us this way when we are trying everything we can to comply and reach a resolution. I asked her what we can expect next. She said she would review the financials and get back to me within 30 days. I asked for her manager's name. She said she will have him call. I said thank you and before I could say anything else, she hung up on me.

04/10/2024 10:48 Received letter from appeals setting a hearing date for 4/24/24

Had hearing with Appeals Officer Victor Hernandez. He said that he agreed that levy was inappropriate & he would get it released. He said he would follow up on that in a couple days.

04/24/2024 13:48 He also indicated that he would get the installment agreement set up and we would receive letter in 10-14 days.

I told him that, in addition, I have also spoken with Appeals so it is definitely in Appeals status.
