The Adobe Acrobat 2017 program currently has a dynamic stamp built in that allows a user to stamp a PDF document that shows it was received, by whom, the date, and time. This tool is currently an option used by RAs in GSA to date stamp documents without printing them. I am also including the FAQ from SB/SE stating it has been used for the past several years.

I just got back to the office this morning.

Here is a summary of the responses I received from the EO Exam senior managers:

- While I'm not familiar with this tool, it does sound like it would promote all electronic case files and eliminating unnecessary printing.
- I like it! The future is an electronic environment so the earlier we begin to transition the better.
- When I was in manager in EP Exam, our group the pdf tool to electronically stamp the information that was received. Not all information had to be electronically date stamped, but the ones that did we used that pdf tool. This was helpful to stamp documents when the RAs were in the field and received items through e-fax to their email.
- I am not familiar with the Electronic Date Stamp, but it sounds like it would be beneficial to EOE as we have increased the use of electronically receiving information.

I sounds like some of our folks already use this in TEGE, but it could be used more widespread especially now with the amount of telework that is being done."

Message from Counsel on 6/26/2020

Implementation of an electronic date stamp to replace a particular external stamp requirement in our litigation function would require GLS/P&A to perform comprehensive review on whether an electronic date stamp would be adequate and meet the statutory requirements of a particular document or process. SFRs went through this analysis and IRS determined it had authority to replace the traditional seal with an acceptable electronic software. Most of Counsel's internal documents do not have this stamp requirement if they are accepted electronically (B/C of pandemic OPM is reviewing all of the pen & ink requirements for personal actions as we speak but Counsel cannot make changes until authorized by OPM).

RCPM/RCEO is already re-routing eFaxes from local printers to shared folders to research and upload the eFax documents into RGS. There is no requirement for these to be physically printed and stamped prior to processing. eFax documents are 'date stamped' as they are received and generate a cover sheet with that date on it. This is used to update the document in our inventory. This suggestion is already in place.

<b>Title:</b>	Electronic Date Stamp scope of use
<b>Procedure:</b>	While the advent of e-fax has significantly streamlined processes & reduced costs, there are some aspects of it that are hindered by regulations that do not take the new technology into account.



One of these is the date stamp. Thousands of documents are e-faxed each day. Many of those require an official date stamp to be affixed to the document. This requires the employee to print the document & then stamp it with the rubber stamp in the office. The printing of the document itself negates most of the benefit for e-fax. Then, if the employee is teleworking, they need to put the documents aside until they are in the office again to stamp it. This also affects timeliness.

There is an electronic date stamp that has been approved for use by Revenue Officers in processing SFR's & Reconsiderations. The software has a much broader application than that and to limit the scope of it's use to just SFR's & reconsiderations is inefficient.

I propose the use of the electronic date stamp for any document and/or employee that requires an official date stamp.

If the document can be sent electronically either through eFax or email, the employee can stamp the document & send it immediately.

If the document needs to be mailed through the postal service, the employee could stamp it from their telework location and mail immediately without having to wait until they get to the office again.

This will greatly increase productivity, efficiency, quality and reduce costs. All the necessary components of an official IRS received date are on the digital date stamp.

This suggestion, if adopted, would have tangible benefits in equipment, supplies, postage & shipping and salary & benefits.

It would also have intangible benefits in accuracy, business results, customer & employee satisfaction and in job effectiveness.

The original suggestion, while limited in application/scope, was estimated to have a first year tangible savings of \$23,295 and intangible benefits of \$3,000. That was based on usage by only Revenues Officers and only for SFR's & reconsiderations. The implication is that with the application & scope of use unhindered, the service would see exponentially greater benefit.

**Title:** Digital date stamp of returns

<b>Procedure:</b>	<p>Currently when we receive a faxed return for reconsideration we date stamp it &amp; then scan it to email with the 3870 to ASFR Recon for processing.</p> <p>With E-Fax, having to print the return so that we can date stamp it then scan it back in to email seems to defeat it's purpose. I think it would be better to sign the return digitally or use a digital stamp in Adobe and simply attach it to the email.</p> <p>The IRM seems to support this in some places and not in others. 5.1.15.4.4.1 (10-09-2012) "Accepting a Return for Reconsideration Processing" has only the option of date stamping the return with an official stamp.
