§ 5575.11. Petition for *abatement*

No <u>abatement</u> of <u>penalties</u> and interest shall be allowed unless the owner or lienholder petitions the officers set forth in section one hereof for an <u>abatement</u> on or before the fifteenth day of September, one thousand nine hundred forty-nine, and pays all of his delinquent real estate taxes less <u>penalties</u> and interest within thirty (30) days after said officers find as a fact that the value of the said real estate is less than the total of taxes, <u>penalties</u> and interest as of the aforesaid date.
